PART 1.00 DRAWINGS

1.01 Sheet D-1:

- A. Under legend at concrete slab removal and replacement; delete reference to A/D-1. Add note, "see sheet A1-1 for exact locations of slab demolition and replacement and see detail A/A1-1 for replacement detail.

1.02 Sheet A1-3:

- A. Door 19, omit wording "glass door". Door 19 to be wood and glass door WD-2 as per door schedule.
- B. Provide eight (8) 4' corner guards to be located by architect.

1.03 Sheet A2-1:

- A. Change door 20 and 21 to door type WD-4, 20 min. rated with panic and closers.

1.04 Sheet A5-1:

- A. Under Keynotes "D1" to read, "28 GA corrugated deck."

1.05 Sheet RC-1:

- A. "C.O." at Space 120-passage, Space 103-landing, Space 102, stairs, to be ceiling drop of 3 5/8" metal studs @16" o.c. from ±7'-6" A.F.F. to attach to structure above with 5/8" gyp board on both sides and bottom of studs, paint.
