### ADDENDUM NUMBER ONE

The Bidding Documents are modified as follows:

#### PART 1.00 DRAWINGS

##### 1.01 Sheet D-1:

- A. Keynote "7" refers to the two existing wood columns at the covered porch that are existing to remain.
- B. Under wall legend the dashed walls are walls to be removed and the solid line walls are walls to remain.
- C. Remove existing acoustical tile and ceiling on the west ceiling of 118 Main.

##### 1.02 Sheet A1-3:

- A. Under Room Finishes, provide a cash allowance of \$1,500 for purchase and installation of new sealer on all existing concrete floors after floors are cleaned.
- B. Under Food Service Equipment Schedule, items 45, 46, 47, 48, and 49 are to be provided by owner and installed by mechanical contractor. All associated ductwork for hood to be provided by owner and installed by mechanical contractor.
- C. Hostess cabinet is not in contract.
- D. Replace broken glass at exterior near Door 1 and 2.
- E. At can wash provide quarry tile floor and 6" high quarry tile base all in silicone grout; epoxy paint on walls of can wash.
- F. Note at kitchen, dishwasher, cooler area, and back entrance, provide 6" high quarry tile base in silicone sealer and epoxy paint up to 11'-0" A.F.F. regular paint above on all walls in these spaces

##### 1.03 Sheet A2-1:

- A. Provide a cash allowance of \$4,000.00 for purchase and installation of all door hardware.
- B. Door type WD-3 is not used; door type WD-4 is used.

- 1.04 Sheet A3-1:**
- A. Detail C/A3-1, new windows on both side of double doors to be wood fixed windows with insulate, clear, tempered, 5/8” thick glass in wood frame and trim.**
- 1.05 Sheet A3-2**
- A. Detail A/A3-2; curtain against wall to be provided and installed by owner.**
  - B. All spaces in the project are to receive RB 618 wood base painted throughout as also picture mould mounted at approximately 11’-0” A.F.F. (Painted).**
  - C. Detail C/A3-2 there is no light box across top of double doors in this elevation.**
  - D All stainless steel panels will be provided by owner and installed by contractor on contractor provided framing and plywood. All stainless steel skirt and ceiling panels at hood to be provided by owner and installed by G.C.**
  - E. Exhaust duct for dishwasher to be provided by owner and installed by Mech. Subcontractor**

- A. Detail 3/A3-3; contractor to provide track light and all wood framing around track light. Fabric and rod pocket to be provided by owner and installed by contractor.**
  - B. Detail 5/A3-3, contractor to provide plywood base for fabric fin. Fabric to be provided and installed by owner.**
  - C. Detail 6/A3-3, owner to provide and install curtain fins.**
  - D. Detail 8/A3-3 owner to provide fabric for ceiling clouds. Contractors to install fabric on plywood.**

- A. Details 1/A3-4, 3/A3-4, provide 6” high quarry tile base in silicone grout around inside of bar area.**
- 1.08 Sheet RC-1:**
- A. Stainless steel sheets at ceiling to be provided by owner and installed by contractor**

- A. Detail 1/FS-1; all stainless steel panels, skirts, sheets to be provided by owner installed by contractor.**

- A. General contractor to provide a cash allowance of \$7,500 for tapping fees for City of LaGrange cost.**
